Information about vacancies, qualifications and other eligibility criteria, pay level, application process and methodology & other terms and conditions of the recruitment is given below.

1. NATIONALITY/CITIZENSHIP

- A candidate must be either:
 - (i) A citizen of India, or
 - (ii) Subject of Nepal, or
 - (iii) A subject of Bhutan, or
 - (iv) A Tibetan Refugee who came over to India, before the 1st January, 1962 with the intention of permanently settling in India, or
 - (v) A person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka, East African Countries of Kenya, Uganda, the United Republic of Tanzania (Formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire, Ethiopia and Vietnam with the intention of permanently settling in India.
- Provided that a candidate belonging to categories (ii), (iii), (iv) and (v) above shall be a person in whose favor a certificate of eligibility has been issued by the Government of India.
- A candidate in whose case, a certificate of eligibility is necessary may be admitted to the Test, but the offer of appointment will be given only after, the necessary eligibility certificate has been issued to him/ her by the Government of India.

2. APPLICATION FEE

SC/ST/PwBD and Women candidates are exempted from payment of application fee as per GoI orders. ICMR employees are not exempted from the payment of the fee.

All other applicants must pay a non-refundable application fee in the form of Indian Postal Order/Demand Draft amounting to **Rs. 300/- (Three hundred)** only in the favor of "**Director, ICMR-RMRC, Dibrugarh**" and payable at Dibrugarh. The application fee once remitted shall not be refunded under any circumstances.

3. AGE RELAXATION

Age relaxation permissible beyond the Upper age limit are as follows:

- i. Age relaxation up to 5 years for Scheduled caste (SC) and up to 3 years for Other Backward shall be allowed as per DoPT guidelines. Candidates belonging to SC/OBC (Non-Creamy Layer)/EWS should furnish their certificates in the prescribed format, failing which, their applications will not be considered.
- ii. Age relaxation up to 5 years for Group 'B' post and up to 40 years for Group 'C' posts are allowed to the Government servant shall be allowed subject as per DoPT guidelines. This concession is admissible to such of the Governments servants as are working in posts which are in the same line or allied cadres and where a relationship could be established that the service already rendered in a particular post will be useful for the efficient discharge of the duties of posts.
- iii. Persons working in ICMR projects continuously shall be eligible for age relaxation up to five years provided he/she has entered into project service within prescribed age limit for the post.
- iv. The age relaxation for reserved category applicants is admissible only in the case of vacancies being reserved for such categories. The reserved category applicants, who apply against unreserved vacancies, will get age relaxation to the extent it is available to UR category candidates.

4. HOW TO APPLY

The candidates applying for the post should first confirm their eligibility as per advertisement on the website of the Centre or ICMR. They should also ensure that they have a valid personal e-mail ID and mobile number. Candidate should note that the e-mail ID and mobile number are to be kept active during the recruitment process. The candidates should ensure that the email ID is not shared or disclosed to anybody. In case, a candidate does not have a valid personal e-mail ID, he/she should create his/her new e-mail ID before applying online. The e-mail ID is required for the communication purpose.

- a) All eligible candidates willing to apply in response to this advertisement notice for the posts of Technical Assistant, Technician-1 and Laboratory Attendant-1 should visit Institutes website at <https://rmrcne.org.in> and register himself/herself via the



“Online Registration” link before the last date for registration of application form i.e. **09/08/2023** and generate a Registration Number.

b) Thereafter, candidates have to download the Application Form from the Institute’s website and a printed copy of the filled offline application form duly signed by the applicant along with relevant enclosures and non-refundable application fee in the form of Indian Postal Order/Demand Draft of Rs. 300/- (Rupees Three hundred) only should be sent in a sealed envelope cover super scribing “Application for the post of..... (name of the post), (Registration Number)” to **“Director, ICMR-Regional Medical Research Centre, Bokul, Lahowal, Dibrugarh – 786003, Assam”** through speed post/Registered post (applications by hand will not be received) latest by **12/08/2023**.

c) The candidates need to attach the self-attested copies of the following documents along with their duly completed Application Form: -

- Proof of Date of Birth
- Proof of Educational qualification from Class-Xth onwards
- Proof of Work Experience certificates
- Proof of Experience for age relaxation for the candidates working in Government Sector; in the prescribed format
- Income and asset Certificate for EWS candidates, in the prescribed form at
- One-self attested recent passport size photograph
- Proof of Category i.e. SC/ST/OBC (Non-Creamy) /PwBD/EWS etc. in prescribed format
- No Objection Certificate (wherever applicable)
- Declaration of Experience for Candidates working in ICMR projects continuously
- Any other document relevant to the essential qualification and eligibility criteria.

d) The candidates have to fill all the columns in the application form and should write ‘NA’ in respect of the clauses which are not applicable or relevant to the candidate.

f) Only applications received by **speed post / registered post** will valid Registration Number will be accepted. No other mode of application will be considered.

g) Applicants must register separately and submit separate application for each post.

h) Those working in Central/State Government Department, Public Sector undertakings and Government funded organization should be submitting their applications with the prior permission of the employer and submit **No Objection Certificate** along with application form and other essential documents.



5. IMPORTANT NOTES

1. CBT (Computer Based Test) will be conducted for 100 marks.
2. 95 percent weightage will be given to the marks scored by the candidate in the CBT (Computer Based Test), and 5 percent weightage will be given for research/Lab/filed experience in any Government recognized/approved/registered institution or organization obtained after meeting the essential qualification as prescribed in the recruitment rule/advertisement.
3. The 5 percent weightage for post Essential Qualification research/Lab/field experience in any Government recognized/approved/registered institution or organization will be added to the marks scored by the candidate in the CBT as mentioned below:

4. Candidates selected for appointment are liable to serve anywhere in India i.e. all these posts carry All India Service Liability (AISL).
5. All information relating to this recruitment right from the status of application up to the nomination of the selected candidates to the initial place of posting including call letters for the Computer Based Test, to the provisionally eligible candidates will be available on the website of ICMR-RMRC Dibrugarh at <https://rmrcne.org.in>. ICMR-RMRC Dibrugarh will not be responsible for information available from other sources.
6. Any Addendum/Corrigendum/updates, all information regarding declaration of results for short listing of candidates based on CBT will be displayed on the Institutes website at <https://rmrcne.org.in> and ICMR's website at <https://main.icmr.nic.in>. Candidates will not be informed individually in this regard. Therefore, candidates are advised to regularly visit websites of ICMR-RMRC Dibrugarh and ICMR for any updates.
7. All applicants are advised to read these Guidelines and the advertisement document carefully before starting online registration and ensure that no column is left blank and all the columns in the REGISTRATION FORM and APPLICATION FORM are filled in correctly as once registered / submitted, candidates will not be able to change the entries and their candidature will be decided accordingly. In the event of rejection of the



application form due to INCORRECT entries filled by the candidate, no correspondence / request for reconsideration will be entertained.

8. As per Ministry of Human Resource Development Notification dated 10-06-2015, published in Gazette of India all the degrees/diplomas/certificates awarded through Open and Distance Learning mode of education by the Universities established by an Act of Parliament or State Legislature, Institutions deemed to be Universities under Section 3 of the University Grant Commission Act 1956 and Institutions of National Importance declared under an Act of Parliament stand automatically recognized for the purpose of employment to posts and services as notified, provided they have been approved by the University Grants Commission. Accordingly, unless such Degrees are recognized for the relevant period when the candidates acquired the qualification, they will not be accepted for the purpose of Educational Qualification.
9. Applications / candidature of applicants are liable to be cancelled/ rejected at any stage of the recruitment process in the event of all or any of the following:
 - Applications being incomplete.
 - Any variation in the Signatures (signatures done on the Application Form and also on other Documents must be the same).
 - Application without clear photograph and legible signature.
 - Non-payment of Fees by the fee non-exempted candidates.
 - Fee not paid as per instructions.
 - Under-aged /over aged candidates.
 - Not having the requisite educational qualification, experience, age as on the closing date of the application.
 - Incorrect information or misrepresentation or suppression of material facts.
 - For carrying prohibitive items to the Examination premises /Hall.
 - Non-production of original certificates at the time of Document Verification.
 - Indulging in any of the malpractices listed in this Notice.
 - Candidates who are found in an inebriated condition in the Examination Hall.
 - Any other irregularity.
10. The decision of the ICMR-RMRC Dibrugarh in all matters relating to eligibility, acceptance or rejection of the applications, penalty for false information, mode of selection, conduct of Test(s), allotment of examination Centre and preparation of merit list, debarment for indulging in malpractices, initial posting etc. will be final and binding upon the candidates and no enquiry / correspondence will be entertained in this regard.
11. **Disqualification:** No person, (a) who has entered into or contracted a marriage with a person having a spouse living; or (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the service, provided that Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.
