- 2 **Eligibility conditions:** Officers under Central Government or State Governments or Union Territories Administrations or public sector undertakings or universities or recognized research institutions or semi-Government or autonomous or statutory organizations:
- (A)(I) Holding analogous posts on a regular basis in the parent cadre or Department; or
- (II) with two years' service in the grade rendered after appointment thereto on a regular basis in the pay band 2: Rs. 9300-34800 plus Grade Pay of Rs. 4800 or equivalent in the parent cadre or Department; or
- (III) with three years' experience in the grade rendered after appointment thereto on regular basis in posts in the pay band 2, Rs. 9300-38400 plus Grade Pay of Rs. 4600 or equivalent in the parent cadre or Department; and
- (B) Possessing the following educational qualifications and experience:

Essential:

- (I) Degree in Law from a recognized university or institute;
- (II) three years' experience in drafting of acts and statutory rules;

Desirable:

Bechelor of Science with Chemistry as a subject or Bechelor of Science (Agriculture) from a recognized university or institute.

Note 1: Officers of only Central Government or State Governments or Union Territories will be eligible for consideration for appointment on absorption basis.

3. <u>List of duties and responsibilities attached to the post of Law Officer</u> (Fertiliser) are as follows:

- (a) Examination of proposals relating to inclusion of new fertilizers in the Fertilizer (Control) Order, 1985.
- (b) Handling of court cases relating to Fertilizer (Control) Order, 1985.
- (c) Examination of proposals relating to Quality Control of Fertilizers.
- (d) To deal with matter relating to Central Bio-stimulant Committee and Central Fertilizer Committee.
- (e) To examine and to clarify the State Govenments and stakeholders on the various provisions of Fertilizer (Control) Order, 1985.
- 4 **Regulation of pay and other terms of deputation:** The pay of the selected candidate will be regulated under the provisions contained in Department of Personnel and Training's Office Memorandum No. 6/8/2009-Estt (Pay-II) dated 17th June 2010, as amended from time to time.
- 5 <u>Age limit</u>: The maximum age-limit for appointment by deputation (including short term contract) shall be not exceeding fifty-six years on the closing date for receipt of applications.
