III. Application Procedure

1. Step-1 (Application Fees)

Non-refundable application fee is required to be paid by the candidates by way of online NEFT mode in favor of the Executive Director, AIIMS Bilaspur, H.P. Applications without submission of application fees will not be considered and summarily rejected. The application fee applicable to various categories is as follows: -

- Persons with Benchmark Disabilities (PwBD): Exempted from payment of fee.
- ii. SC/ST category: Rs. 2400/- (Inclusive GST)
- iii. For other categories: Rs. 3000/- (Inclusive GST)

- ii. Photo & Signature: The candidate must ensure that their photo and signature are clearly visible. If the photo/signature image is displayed as small or not visible, that means the photo/signature is not as prescribed and, in that case, their application will be rejected. Accordingly, candidates are advised to be very careful while uploading their photo and signature.
- D. Step-4 (Offline Application form)

3. Selection Procedure

- i. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate to be called for interview or for selection. Based on bio-data, the Screening Committee may short-list candidates for interview. If large numbers of eligible candidates apply for any post, then the Competent Authority may hold a screening test to short-list candidates for interview. Candidates called for interview will have to produce all relevant original documents in proof of details furnished in their application at the time of interview. They may also be asked to submit an affidavit/declaration as decided by AIIMS, Bilaspur at the time of Interview. The methodology of Selection will be decided by the Selection Committee as deemed fit besides any other matter related to the selection process.
- ii. The applications and documents of the shortlisted candidates only will be scrutinized w.r.t. the applicable recruitment rules of the concerned post to decide his/her eligibility for the post. Accordingly, based on scrutiny of applications & documents of the shortlisted candidates an ELIGIBILITY NOTICE will be published on Institute's website.

- iii. Only the eligible candidates/ shortlisted candidates will be called for interview/written examination. However, the same would be provisional subject to fulfillment of all requirements failing which he/she will not be allowed to appear for interview.
- iv. Interview letters/Admit card will be sent by post/ through email ID and the complete interview/written examination schedule will also be made available on website also.
- v. The interview with the Selection Committee is mandatory for which the candidate has to appear personally and physically. No request for online interview i.e., through electronic media viz. Skype/Viber etc. will be accepted and no correspondence in this regard will be entertained.
- vi. The decision of the competent authority regarding selection of candidates will be final and no representation will be entertained in this regard. The date and time for interview/written examination will be intimated to the eligible/shortlisted candidates only and the same will also be published on the AIIMS' website (https://www.aiimsbilaspur.edu.in). The information regarding eligibility/short listing of candidates will be published in AIIMS-Bilaspur official website only.
- vii. The selected candidates will be issued appointment letters. The appointment of selected candidates is subject to his/her being declared medically fit by the competent authority.

5. General Instruction

- i. The Executive Director, AIIMS Bilaspur reserves the right to reschedule the above date, time and venue for the selection.
- ii. The candidates must ensure that they fulfil eligibility criteria. If at any stage, it is found that the candidate has furnished any incorrect information his/her candidature will stand cancelled. If any of these shortcoming (s) is/are detected even after the appointment, his/her services will be summarily terminated.
