GENERAL INSTRUCTIONS TO CANDIDATES AND MATHOD OF APPLICATION TO APPEAR IN WALK IN INTERVIEW

- 1. The number of vacancies may be changed without any prior notice.
- 2. No. TA/DA will be admissible either for the 'Walk- in- interview' or for joining the post.
- 3. The Competent Authority reserves the right to fill up all or not to fill up any post or cancel any vacancy /interview at any stage.
- 4. The selected candidates will have to join stipulated date given in offer of appointment.
- 5. The selection is subject to the candidates providing their medical fitness Certificate issued by Medical Board at ESIC Hospital Vapi.
- 6. Candidates must be registered with Medial Council of India before joining the post.
- 7. The candidate who is in the Service should submit "No Objection Certificate" from the employer at the time of interview.
- 8. The selected candidate will have to furnish a DD/Bankers Cheque for an amount of Rs. 30,000/-(Rupees Thirty Thousand Only) drawn in favour of 'ESIC fund A/c No 1' payable at Vapi, towards security deposit.
- 9. Candidate seeking reservation benefits for SC/ST/OBC/EWS must ensure that they are entitled to such reservations per eligibility prescribed in the Notice. - 16. The contractual appointment for part time contractual specialist will be for one year from the date of joining or appointment of regular incumbents whichever is earlier.
