General conditions for Junior Research Fellow:

1. JRF / Project Fellow would be engaged for a fixed period of five months for providing high quality services to the project or for attending the specific and time-bound tasks.
2. The appointment of JRF / Project Fellow would be on full-time basis and appointee would not be permitted to take up any other assignment during the period of project with the GK(DU), Haridwar except pursuing of Ph.D. from GK(DU), Haridwar.
3. The appointment of JRF/ Project Fellow is on purely temporary on co-terminus basis and do not entitle the appointee to any claim implicit or explicit or any post.
4. The appointment can be cancelled at any time by the GK(DU), Haridwar without assigning any reason.
5. The initial term of appointment and subsequent extension(s) if any, shall be decided on case to case basis depending upon the specific jobs as per progress report and the time frame for its completion.
6. The JRF/Project Fellow shall not be entitled to any allowance such as dearness allowance, residence, telephone, transport facility and personal staff etc.
7. The selection of candidate will be made through Interview by selection committee. Date of interview will be communicated to shortlisted candidates via email. No TA/DA will be paid to the candidates for attending the interview.

Candidates have to attend the interview on the date, time, and place at Kanya Gurukul Campus Dehradun, Second Campus of Gurukul Kangri (Deemed to be University), Haridwar, Uttarakhand (which will be intimated on email) with complete bio-data, passport size photograph and original proof of qualifications and experiences.
