Any attempt to submit more than one application by a candidate against a CEN shall result in disqualification and debarment.</p> <p>12.0 Eligibility: Eligibility of the candidates will be provisional based on the details furnished by the candidates in the application. Candidates must satisfy themselves that they are eligible for the post.
