2. **Age limit: RA:** Maximum: 40 years for men; 45 years for women; **SRF:** 35 years for men and 40 years for women. Relaxation in upper age limit to SC/ST (5 years), OBC (3 years), PWD (10 years) and other eligible categories shall be applicable as per GoI/ ICAR norms.
